Devon County Council, Plymouth City Council, Torbay Council and NHS Devon CCG are commissioning for a contract for Local Healthwatch and a Local Engagement Service within the Devon STP footprint. The procurement is divided into 2 Lots:

Lot 1 – **Healthwatch** statutory consumer voice

(Commissioned by 3 local authorities)

Lot 2 – **Local Engagement** activity.

(Commissioned by 3 local authorities and the CCG)

Strategic drivers behind the combined tender:

- Devon STP for whole system.
- Increased health and social care integration.
- Sustainability of consumer voice and local engagement functions.

...resulting in agreement between 3 local authorities and CCG on the need for a Pan-Devon approach to commissioning these consumer voice and engagement activities.

Lot 1. Local Healthwatch

Single infrastructure for independent consumer voice covering the Devon STP area, with discrete public-facing identity and access points for Healthwatch Devon, Healthwatch Plymouth and Healthwatch Torbay.

This Lot is being commissioned by the 3 local authorities with CCG input. The LA's hold the statutory responsibility and it covers Children's and Adults Health and Social Care Services.

Economies of scale and local best practice.

Lot 1. Local Healthwatch

Contract duration: 3 years + 1 + 1 + 1, from 1/4/20.

Current indicative contract value:

Year 1 maximum £560,000

Year 2 maximum £560,000

Year 3 maximum £560,000

Total £1,680,000

We are committed to giving 3 years of funding stability for the setting up of a new infrastructure.

Lot 2. Local Engagement Service

We would like to work in partnership with a provider(s)to support our engagement work.

The provider(s) will work with a wide range of organisations to help often vulnerable people to comment on our plans, processes and services, and to liaise with Healthwatch for relevant public views.

Lot 2. Local Engagement Service

The key distinction between Lot 1 and Lot 2:

The Lot 1 lay-led Healthwatch consumer voice will determine it's own priorities, in consultation with commissioners.

Lot 2 work will be spot-purchased by commissioners who will want specific engagement undertaken and we want maximum flexibility in how this work can be done.

Lot 2. Local Engagement Service

Contract duration: 3 years + 1 + 1 + 1, from 1/4/20.

Current indicative contract value:

This is a spot-purchase contract so there is no funding guarantee but in 2018-19 we commissioned approx. £120,000 of work which would in future come under this contract.




