

## 2223-0248 Black, Asian and minoritised ethnic women Independent Domestic Violence Advocacy (IDVA) service

Islington Council invites suitable expressions of interest from providers for the above named contract.

#### Current status / Background

Islington Council and its partners are committed to the provision of excellent services to address Domestic Abuse (DA). The Black, Asian and minoritised ethnic women IDVA service will be critical in reducing the level and impact of domestic abuse in Islington by increasing the safety of survivors and their families.

#### The requirement

This contract is for a domestic abuse advocacy and support service commissioned by Islington Council.

- The service will be independently developed, led and delivered by and for Black, Asian and minoritised women, promoting social and community cohesion. The service will respond specifically to the needs of Black, Asian and minoritised women who have experienced violence and will reach communities and individuals who face multiple barriers to accessing statutory and other voluntary services.
- The service will provide IDVA roles embedded within Islington's voluntary and community sector settings who will provide support to survivors of violence against women and girls (VAWG) experiencing domestic abuse, sexual violence, female genital mutilation, forced marriage and other oppressive and harmful practices.
- The service will provide one-to-one support to survivors of VAWG and domestic abuse, co-ordinating multi agency support and safety planning by providing practical solutions in Islington.
- This service will meet the needs of and provide services to Black, Asian and minoritised women including transgender women.
- The service will demonstrate anti-racist values through actions and accountability to Black, Asian and survivors from minoritised backgrounds based on collaboration, inclusivity, and intersectional representation.
- Islington Council and partners will work with the provider to develop the service to meet the needs of survivors and their families. To enable us to do this we require a service

provider who is knowledgeable about the impact of VAWG on diverse communities, experienced in delivering domestic abuse services and who will work innovatively to meet the needs of survivors and their families.

- The service provider will demonstrate a clear focus on utilising resources providing the greatest positive impact for survivors and their families.
- The service provider will demonstrate exceptional social value improving economic, social, and environmental wellbeing of survivors and their families.

#### Lots

# TUPE [Transfer of Undertakings (Protection of Employment) Regulations]

## **Contract Period**

The agreement will run for a period of 24 months. It is estimated that the contract will start in July 2023 with the option to extend for up to two periods of 36 months subject to satisfactory performance and available funding.

## **Contract Value**

The estimated maximum total value of this contract is £1,184,000 over the maximum 96 months term of the contract. This is based on £148,000 per annum. Any bids over this amount may be disqualified.

The contract is partially funded by the Mayors Office for Policing and Crime (MOPAC) London Crime Prevention Fund (LCPF). The LCPF grant is allocated to Islington council every 36 months. Current funding has been confirmed from April 2022 until March 2025. Due to the external match funding the contract's length will be initially awarded for 24 months with possibility of extension if LCPF funding is confirmed.

If external match funding is not extended (via MOPAC London Crime Prevention Fund) the annual contract value will be reduced to £88,000 per annum.

Bidders will be required to provide proposed model of delivery and staffing in an event that the funding will have to be reduced.

#### Award criteria

The contract will be awarded to the Most Economically Advantageous Tender (MEAT) in accordance with the Public Contracts Regulations. MEAT for this contract is quality 70% and cost 30%. Further details will be provided in the invitation to tender.

Tenderers should be aware that we reserve the right to hold interviews during the tender process. Interviews will be for verification/clarification purposes of the written submission.

We reserve the right to interview leading bidders.

#### **Procurement Process**

This procurement will be conducted in accordance with the Public Contracts Regulations 2015, under Chapter 3 Section 7 Social and Other Specific Services (known as the light touch regime). Under Regulation 76 the council is free to establish a procedure, provided that the procedure is sufficient to ensure compliance with the principles of transparency and equal treatment of economic operators (service providers).

The procedure will be based on a one stage tender. As per the open procedure, any interested economic operator (service provider) may submit a tender in response to the advertisement.

Those who submit a tender and meet the minimum requirements will have their full tender, method statements and pricing evaluated.
