### **Torbay's Economy**

- One of the lowest levels of GVA and gap widening
- 41% of our workforce work part-time
- Outward migration of working age population
- Only 8% of our population are aged 16-24
- 1 in 4 people live in the most deprived areas
- Nearly 50% of our population are aged 50+
- Opportunity sectors around photonics, tourism, health, fishing



### **Torbay's Economic Growth Strategy - priorities**

- Building on our economic specialisms
  - Build on our key sectors, support start up, growth and innovation in these sectors
- Helping our community to reach their economic potential and build an inclusive economy
  - Enable our people to find work and better work, tackle poverty and reduce disadvantage

Objective	Strengthen social fabric and fostering a sense of local pride and belonging
Outputs	4 neighbourhood improvements undertaken
	100m2 of new green/blue/ space created
Outcomes	10% increase in footfall
	10% increase in improved perception of facilities
	50% increase in user facilities
Funding	£20,800
Cap/rev	capital
Spend dates	22/23
Supplier requirements	A supplier or suppliers to use the capital funding to make improvements to a minimum of 4 community projects or spaces. The improvements should cover a minimum of 100m2 and monitor and deliver the outcomes required.

Supplier requirements	A supplier is required to help local volunteering groups access financial support, grants, deliver events that drive volunteering opportunities and deliver the outputs and outcomes required.



# Low value E10: Funding for local sports facilities, tournaments, teams and leagues, to bring people together

Outputs	2 facilities supported/created 15% increase in participation in sports and recreational activities at facilities that have benefited from funding
Outcomes	20% increase in engagement users  90 volunteering activities/events/incidents
Funding	£45,723
Cap/rev	capital
Spend dates	22/23-23/24
Supplier requirements	Up to 2 community based sports organisations can tender for capital funding that results in increased participation and delivers the outcomes

Objective	Creating jobs and boosting community cohesion, through investments that build on existing industries and institutions, and range from support for starting businesses to visible improvements to tourism, hospitality and leisure sector facilities.

Supplier requirements	A supplier or suppliers can utilise this funding to develop a trails or invest in attractions that leads to demonstrable increase in footfall, ideally in the shoulder season. It should also create 1 extra job, safeguard 2 and deliver the other outcomes required.
