Torbay Council is looking to carry out the following works at Mayfield School:

The works will consist of the following:-

- Strip and Pad Foundations, Concrete Floor Planks, Steel Frame, Contractor designed SFS systems, Rainscreen panels, posi-joists, Bauder flat roof, Bridge Structure, Aluminium external doors and windows, internal stud partiting. Suspended ceilings, floor screed and floor finishes. Internal decorations and fittings. Lower Ground Storage Area.
- Contractor designed Mechanical, Electrical and Plumbing systems based on TDA Performance Specifications. Including air source heat pump and underfloor heating. Ventilation to certain rooms. Plumbing systems, Electrical works to include power, data and lighting. Lightning Protection.
- External works Temporary removal and reinstation of play equipment, New access path consisting of some suspended areas to follow contours, Drainage including drain diversion and surface water attenuation. Landscaping. Fencing. Artificial Grass
