

Contract Title: CS5217 - Supply of Special Educational Needs or Disability (SEND) Youth Activity for Young People Aged 12 To 25

The London Borough of Tower Hamlets (the "Council") is seeking expressions of interest from interested organisations for the above services.

Description:

The contract is for the supply of special educational needs or disability youth activities for young people aged 12 to 25. The successful tenderer shall supply young people with access to free positive activities and informal educational courses in the form of an evening programme (the "programme") enabling them to have places to go and things to do. The programme offered should be stimulating, interesting and fun and will include a range of opportunities to enable young people to develop socially, physically and intellectually.

The programme shall be provided for the contract period 1st April 2017 to 31st March 2018 inclusive; with the option to extend for a further 12 months until 31st March 2019.

The contract shall be awarded to one contractor who will make the programme available to young people who live, or go to school/college or regularly attend a youth centre in the London Borough of Tower Hamlets.

The maximum available budget for the period 1^{st} April 2017 – 31^{st} March 2018 is £50,000. There is an option to extend this contact by a further 12 months to 31^{st} March 2019 and if the option to extend is taken then the maximum available budget available for the extension period will be £50,000. The total maximum value of this contract including the option to extend is £100,000.

Young people have told the Council that they want to participate in youth activities in high quality venues. As a result, the contractor shall ensure that the *programme* is delivered in a high quality venue which is young person friendly.

The contractor will be responsible for the costs associated with all venues utilised as part of the contract.

A key target for this contractor will be the achievement of a minimum of 100 *contacts* with young people per ward.
