## 4. Other Requirements / Special Conditions

- 1. Service to be operated by low floor, wheelchair accessible vehicle(s). The vehicle(s) used on this contract should be suitable to operate the specified route(s).
- 2. The journey(s) on this contract will operate on school days only, and it is the responsibility of the operator to ascertain the requirements of the school in that respect.

## 5. Vehicle Engine

The engine(s) of the vehicle(s) used on this Contract must be of Euro 4 standard as a minimum and not as set out in the Conditions of Contract.

#### 6. Fare Levels

The fares to be charged should not exceed Merseytravel's maximum scale as specified by the Supervising Officer.

#### Children

One child under five years may travel free with a fare-paying passenger, pass-holders being deemed to be a fare-paying passenger.

Young persons aged 5 to 18 years inclusive shall be carried at a charge of no more than half the adult fare (after allowing for rounding to the nearest penny) payable for journeys wholly within the area bounded by Liverpool, Sefton, St Helens, Knowsley and Wirral MBCs at any time.

The maximum fare scale may be varied from time to time by Merseytravel in accordance with the Conditions of Contract.
