I/We undertake to hold this offer open for acceptance for a minimum of 90 days from the date fixed for the submission of tenders.

I/We hereby declare that

- (a) the necessary licences, permits, insurances etc. for the performance of this Contract are held and that they will be renewed as necessary so as to remain in force at all times during the performance of the Contract. I/We also agree that The Director may inspect the said licences, permits, insurances etc. at any reasonable time.
- (b) the vehicle(s) to be used in performance of the Contract are in roadworthy condition, comply in all respects with current legislation, bylaws etc., relating to the performance of this Contract and will be so maintained at all times during performance of this Contract. I/We also agree that The Director may inspect the records of inspection and maintenance of vehicles at any reasonable time.
- (c) the tender price quoted has not been calculated by agreement or arrangement with any person, nor communicated to any person other than the Council, and will not be communicated to any person until after the closing date for tenders.
