Overview

Winchester City Council invites expressions of interests from contractors by completing the suitability questionnaire. You are required to prepare a response no later than 12:00pm Monday 02 October 2017. Following the completion of the suitability questionnaire, a number of contractors will be invited to tender for the works.

The Mayles Lane, Knowle project comprises of the detailed design and construction of 13 affordable housing units, across three sites near Mayles Lane, Knowle, Fareham, Hampshire, including all associated drainage, external works, landscaping and main services. Full planning permission has been obtained for two of the three sites (Park Cottages 17/00958/FUL & Land Adjacent to Dean Villas/Totsome Cottages 17/00957/FUL). Land South of Knowle Village Business Park is awaiting ecology surveys before the final decision notice can be issued. However, the draft planning conditions for this site have been received.

Works will be carried out under a fixed price lump sum in accordance with the terms and conditions of a JCT Design and Build Form of Contract, 2016 edition, including all amendments current at the time of tender, and amended in accordance with Winchester City Council's specific requirements.

The proposed procurement route will be based on a single stage approach with tender documentation (specification and drawing) targeted for issue 13 October 2017.

The pre-tender estimate for the complete design and build package is in the region of £2m.

 - Current Insurances (including professional indemnity)
 - Audited accounts for the last 3 years
 - Health and safety records for the last 5 years
 - Statement confirming any reportable HSE incidents

2. Describe your approach to developing in close proximity to existing housing.

3. Describe how you would manage a Design and Build contract and resolve issues that occur during the 12 month Rectification Period.

Relevant schemes will have been developed to planning stage (RIBA Stage 3) and as a result the contractor will have provided design development.
