Re: Invitation to Ilford Market Management Operator Supplier Engagement Event

London Borough of Redbridge is aiming to launch a new 40 stall high guality street market in Ilford Town Centre in Autumn 2021. We want to work with the best market operators to develop and provide a market to complement the existing vibrant town centre, including all major retailers and an exciting new Mercato Metropolitano food and leisure centre in the Cultural Hub.

If you are a market operator, we want to meet and work with you.

We are hosting a 'Meet the Buyer' event for potential Market Operators as a face to face event and the event will also be open to join online via Microsoft Teams. The event will take place:

10.30am -12.30pm Wednesday 21st July 2021 at Lynton House, Ilford. The event will provide Market Operators with the opportunity to hear more about the project and to ask questions. The Event agenda is within.

We will provide presentations about the newly refurbished town centre public space, market facilities, the Ilford Market project and the Council's aspirations for a Market Management Operator contract.

We are keen to receive the views of all potential market operators. Our aim is to develop a high-quality market to enhance our commercially active town centre. Feedback from operators will contribute to our design of the tender process and help us understand the level of interest from market operators.

Background Information

The impetus to deliver a new market on High Road Ilford is a part of the wider regeneration of the town centre. The public realm has been refurbished to a high standard including new public seating and facilities, planting and greening, state of the art street lighting and infrastructure to support a new 40 stall market. The improvements focus on quality of provision and a more environmentally sustainable town centre.

Ilford station is on the Elizabeth Line, with central sections of the Line planned to open early in 2022.

In late 2018 consultations with the public, existing traders and local businesses recommended a change in operational policy and the delivery of a new market facilitated by an experienced and innovative market operator. This coincided with refurbishment of the town centre and the previous market ceased operations in March 2019.

Redbridge now aims to re-establish Ilford Market including a focus on:

- High Quality of goods, services, layout and stall design
- Green innovation, recycling and reduction in single use plastics
- Support for business 'start-up' initiatives for local residents
- Delivering social value
- Promoting night time economy by having, night time events or market days to complement llford late business day and the Mercato Metropolitano offering

The improved method of operation under the Food Act 1984 incorporates a more appropriate legislative framework to provide street markets. The Act permits an 'arms-length' established operator to deliver the day to day operation of the market. Previously, Ilford could only host restrictive 'market events' and licensed street traders under the London Local Authorities Act 1990. A recent consultation survey aimed at residents, businesses and traders, provided over 300 responses confirmed the days, times, style and an overwhelming desire for a new high quality provision of a new street market.

Timeline of the project.

The project is currently in the pre-tender phase with tender invitations opening at the end of July 2021 with the proposed contract award to the new market operator in October 2021.
