Commercial Update – Stages Lots 1 - 8

Establish Framework Agreement for lots 1-8

Proposed length: 4 year Framework Agreement with 4 year call-off contracts available. A reduction from 8 years previous proposed.

Restricted Procedure

Selection Questionnaire (SQ) - selection phase

Invitation to Tender (Weightings: 50% Wearer Trials, 25% Method Statements, 25% Price)

Commercial - Evaluations

Stage 1

Selection Questionnaire (SQ) Stage

- Company Information
- Financial stability (turnover, profitability, cash flow, liquidity) to be undertaken by independent financial experts
- Technical and Professional Ability (previous experience, quality standard)
- Compliance to requirements of Modern Slavery Act
- Social Value

Stage 2

• Invitation to Tender (ITT)

- Compliance to specification
- Logistics solution
- Stock resilience
- Order processing
- Management information
- Ability to meet demand

Stage 3

Wearer Trial Evaluations

- Comfort
- Overall fit
- Durability



Commercial Update – Stages Lot 9

Establish Dynamic Purchasing System for lot 9

Proposed length: 4 year DPS with option to extend by up to a further 4 years (8 year total), with 4 year call-off available.

DPS Procedure

Selection Questionnaire (SQ) – selection phase only to be shortlisted in the DPS Requirement to submit a tender only at call-off stage

Dynamic Purchasing System (DPS)

Initial DPS Set Up Stage

- Suppliers request to participate in response to the Contracting Authority's OJEU/ Find a Tender Notice;
- All suppliers who meet the selection criteria and do not satisfy any of the grounds for exclusion are admitted into the DPS;
- At this initial stage, suppliers are not required to submit 'indicative tenders';
- The general rule is that the Contracting Authority must make a decision of whether or not to admit a supplier into the DPS within ten (10) working days from receipt of the Request to Participate (RTP) Period can be extended to twenty (20) working days

Second Stage – Awarding Call Off Contracts

- The Contracting Authority must invite all suppliers admitted into the DPS to bid for a contract OR to all suppliers under a specific category;
- Awarding contracts are procured by way of a mini-competition. Direct award is not permitted;
- Contract award notices can be published individually or grouped and published in regular intervals (i.e. quarterly)



Dynamic Purchasing System (DPS)

Admitting Suppliers into an Established DPS

- Suppliers are entitled to join at any point during the validity period of the DPS;
- The call for competition will be continue to be 'live' and unrestricted access to the procurements documents must be available at all times;
- The Contracting Authority must notify the supplier 'at the earliest possible opportunity' whether they have been successful in their Request to Participate ('RTP');
- The supplier will be formally added into the existing DPS supplier list and will be able to bid for contracts only after they have been formally notified that they were successful in their RTP.



Evaluation process— Setting up the DPS

Stage 1

 Request to Participate ("RTP") Stage - Evaluation of RTP submissions against the Selection Questionnaire ("SQ") criteria (including legal eligibility, financial standing and organisational policies and procedures)

Stage 2

 Award Stage – Notify suppliers if their RTP has been successful or not at the earliest opportunity. OJEU and Contracts Finder Contract Award Notice released confirming the establishment of the DPS and the initial list of suppliers who have been admitted to the DPS



Evaluation process – DPS Call off Contracts

Stage 1

- Issue Invitation to Submit Tender ("ITT") document to all DPS suppliers OR to all DPS suppliers under the relevant category
- Receipt of ITT submissions within ten (10) calendar days (may be reduced by mutual agreement)
- Evaluation of ITT submissions against the minimum technical and quality requirements

Stage 2

- Wearer Trial Evaluation (optional, only if deemed necessary by the Contracting Authority)
 - Comfort
 - Overall fit
 - Durability
 - Protection

Stage 3

- Pricing Evaluation
- Overall moderation and identification of the winning contractor
- Ten (10) day standstill period (optional but advisable for high value contracts)
- Release of OJEU and Contracts Finder Contract Award Notice



Practical - Evaluations

- Right to attend wearer trials
- Ratio of those participating in wearer trials
- Number of individual items required, non branded
- Availability of products
- Exercises being carried out include:
 - Mobility exercises
 - Dexterity exercises (gloves only)
 - Practical scenarios



Main Drivers for timeline:

- Statutory requirements
- Practical evaluations:
 - 1 week sizing
 - 12 weeks manufacturing
 - 1 week fitting
 - 3 weeks wearer evaluations


