**Description:** The PLACE project is for the temporary use for housing of the many sites in London that have a long-term, but no short-term use – we call these "meanwhile" sites. The PLACE project is for the development of a range of demountable and reusable blocks of two- and three-bedroom flats that can be repositioned from time to time in response to the ebb and flow of the meanwhile sites. The initial funding is for the manufacture and deployment of 200 homes, with a potential for an additional 100, as a proof of concept. PLACE is procuring a range of services in support of this project, this opportunity for certification and inspection services is one.

This tender is for professional services in connection with the design, manufacturer and deployment of the units, in particular:

- 1. Oversight of the design to ensure that its building Regulation compliant;
- 2. Inspection and quality control of the off-site manufacturing process;
- 3. Providing Building Control services in connection with the site / deployments works
- 4. Inspection and quality control of the site / deployment works


It is intended that the successful tenderer will be appointed for a 5-year term starting in early 2019.
