**Details -** The Council is looking to establish a service delivery model which better suits the changing need of the department and that of our expanding client group. The requirement is split into two distinct parts and has been separated into 5 contracted Lots,

- Lot 1 Provision for Managing Agent Services at Howbury Accommodation Centre
- Lot 2 Provision for Managing Agent Services at Betsham Accommodation Centre
- Lot 3 Provision of Block contract(s) for the provision of temporary accommodation
- Lot 4 Framework for the Provision of Temporary Accommodation
- Lot 5 Provision for Management of temporary accommodation housing stock

# **Contract period**

The contract for Lots 1 2 3 5 will run from 3<sup>rd</sup> May 2022 until 2<sup>nd</sup> May 2025 with the option to extend up to a further 24 months

The contract for Lot 4 will run from 3<sup>rd</sup> May 2022 until 2<sup>nd</sup> May 2025 with the option to extend up to a further 12 months

### **Contract value**

E.G: The estimated value of the contract is circa £16 million per annum.

Tenders are being invited using the (Reserved) procedure and a contract notice has been published in the Find a Tender.

# **Health and Safety at Work**

In meeting the duties placed by the Health and Safety at Work etc Act 1974, and subordinate legislation, the London Borough of Bexley (LBB) has selected the pre qualification schemes that form the Safety Schemes in Procurement Forum (SSIP) as the minimum standards of Health and Safety competence required.

Compliance with any one of these standards, details of which are available on the SSIP website, demonstrates an understanding of health and safety law and it's application in the working environment. As far as LBB is concerned the most common standards used are the Contractors Health And Safety Assessment scheme (CHAS), EXOR Health and Safety and OHSAS 18001 (http://www.bsigroup.com/en-GB/ohsas-18001-occupational-health-and-safety/)

If applicable - Only companies suitably registered (with regards to Health and Safety) by an SSIP Forum member as 'Compliant' (this compliance must also be 'valid' ie assessed within the last 2 years) shall be invited to tender, therefore any application your company may need to make to any of these bodies must be completed successfully by the date any tender is issued. The LBB will carry out a final check on registration just prior to tender invitation and companies not suitably registered at that time will not be invited to tender.

Contractors are expected to maintain a compliant registration (with regards to Health and Safety) with an SSIP Forum member for the duration of any contract.

The SSIP Forum acts as an umbrella organisation to facilitate mutual recognition between health and safety pre-qualification schemes wherever it is practicable to do so.
