THE DISTRICT COUNCIL OF FOLKESTONE AND HYTHE of Civic Centre, Castle Hill Avenue, Folkestone, Kent CT20 2QY ("the Council") and

**GREEN GNOMES LTD** registered number 13640409, whose registered office is at 1-4 Buxhall Business Park, Buxhall, Stowmarket, Suffolk, England, IP14 3BW ("the **Provider**")

(hereinafter collectively "the Parties")

## **WHEREAS**

- The Council entered into an agreement with the Provider for the provision of Pas2035
  Retro-Fit Coordinator Services on the 1<sup>st</sup> of November 2022 ("the Agreement") with a
  Term (as defined in the Agreement) commencing on 1<sup>st</sup> of November 2022 and expiring
  on 30<sup>th</sup> of June 2023.
- 2. The Council wishes to extend the Term until 31st of October 2023 and vary the terms of the Agreement.

IN CONSIDERATION OF THE VARIOUS UNDERTAKINGS, WARRANTIES AND PAYMENTS MADE BY THE PARTIES, it is agreed between the Parties as follows:

- 1. The Parties agree that the Term shall be extended from 1<sup>st</sup> of July 2023 and expiring on 31<sup>st</sup> of October 2023 ("the Extended Term").
- 2. The additional works to be provided and cost are as follows;
  - a. Initial measure selection for x35 homes £1,225+vat
  - b. RC Consultancy service to review, amend and remodel x35 homes in accordance with the RdSAP £2,275+vat
  - c. RC complete service to include initial measure selection, RC consultancy service to review, amend and remodel, PAS compliance check and lodgement fees for the additional 18x homes £4,950+vat
  - d. RC consultancy service to review, amend and remodel x32 homes in accordance with the RdSAP £2,080+vat
- 3. The Parties accept that other than as provided for in this Agreement to extend and vary the Agreement, the terms and conditions of the Agreement shall remain in force in identical terms throughout the Extended Term.
- 4. This Agreement to extend and vary the contract shall be without prejudice to any additional rights of the Council to vary the terms further in accordance with the Agreement.
