THIS EXTENSION is made the 23rd day of November 2023

THE DISTRICT COUNCIL OF FOLKESTONE AND HYTHE of Civic Centre, Castle Hill Avenue, Folkestone, Kent CT20 2QY ("the **Council**") and

GREEN GNOMES LTD registered number 13640409, whose registered office is at 1-4 Buxhall Business Park, Buxhall, Stowmarket, Suffolk, England, IP14 3BW ("the **Provider**")

(hereinafter collectively "the **Parties**")

WHEREAS

- 1. The Council entered into an agreement with the Provider for the provision of Pas2035 Retro-Fit Coordinator Services on the 1st of November 2022 ("the **Agreement**") with a Term (as defined in the Agreement) commencing on 1st of November 2022 and expiring on 30th of June 2023.
- 2. The council extended and varied the term of contract from 1st of July 2023 to the 31st October of 2023.
- 3. The Council wishes to extend further the Term until **31**st **of December 2023** and vary the **terms** of the Agreement.

IN CONSIDERATION OF THE VARIOUS UNDERTAKINGS, WARRANTIES AND PAYMENTS MADE BY THE PARTIES, it is agreed between the Parties as follows:

- 1. The Parties agree that the Term shall be extended from 1st of November 2023 and expiring on 31st of December 2023 ("the Extended Term").
- 2. The additional works to be provided and cost are as follows;
 - Undertake 50 Post Install EPC Assessment & lodgement for SHDF Wave 1.
 - Cost per EPC Assessment of £130 per property totalling £6,500.
- 3. The Parties accept that other than as provided for in this Agreement to extend and vary the Agreement, the terms and conditions of the Agreement shall remain in force in identical terms throughout the Extended Term.
- 4. This Agreement to extend and vary the contract shall be without prejudice to any additional rights of the Council to vary the terms further in accordance with the Agreement.
