## Scottish Public Bodies

The framework agreement will be available for use by any Scottish Public Sector Body: the Authority; Scottish Non-Departmental Public Bodies; offices in the Scottish Administration which are not ministerial offices; cross-border public authorities within the meaning of section 88(5) of the Scotland Act 1998; the Scotland Office; the Scottish Parliamentary Corporate Body; councils constituted under section 2 of the Local Government etc. (Scotland) Act 1994 (except where they are acting in their capacity as educational authority); Scottish joint fire boards or joint fire and rescue boards; Scottish joint police boards or any successor National Police or Fire Authority; Scottish National Park authorities, bodies registered as social landlords under the Housing (Scotland) Act 2001, Scottish health boards or special health boards, Student Loans Company Limited, Northern Lighthouse Board, further or higher education institutions being fundable bodies within the meaning of section 6 of the Further and Higher Education (Scotland) Act 2005 any public body established by or under the Scotland Act 1998 or any Act of the Scottish Parliament, any association of or formed by one or more of the foregoing, bodies financed wholly or mainly by one or more of the foregoing, bodies subject to management supervision by one or more of the foregoing and bodies more than half of the board of directors or members of which, or, in the case of a group of individuals, more than half of those individuals, being appointed by one or more of the foregoing.

<p>Any corporation established, or a group of individuals appointed to act together, for the specific purpose of meeting needs in the general interest, not having an industrial or commercial character, and</p> <ul style="list-style-type: none"> <li>i. financed wholly or mainly by another contracting authority listed above in this section VI.3 of this notice;</li> <li>ii. subject to management supervision by another contracting authority listed above in this section VI.3 of this notice; or</li> <li>iii. more than half of the board of directors or members of which, or, in the case of a group of individuals, more than half of those individuals, are appointed by another contracting authority listed above in this section VI.3 of this notice;</li> <li>iv. an association of or formed by one or more of the Contracting Authorities listed above in this section VI.3 of this notice.</li> </ul>	
<p>Entities which are not public sector bodies may also use the Framework Agreement if the Authority is satisfied that:</p> <ul style="list-style-type: none"> <li>i. such entity is calling-off goods and services directly, solely and exclusively in order to satisfy contractual obligations to one or more public sector bodies, all of which are entitled to use the Framework Agreement on their own account;</li> <li>ii. all goods to be called-off by it are to be used directly, solely and exclusively to provide energy at sites occupied by such public sector body/bodies; and</li> <li>iii. it will pass the benefit of the call-off contract to such public sector body/bodies directly, in full and on a purely 'pass-through' basis.</li> </ul>	

Accordingly there must be no mark-up, management fee, service charge or any similar cost solely in relation to the supply of energy imposed on the relevant public sector body/bodies, who must be able to benefit from the terms of the Framework Agreement in a like manner and to the same extent as if using the Framework Agreement on its/their own account.
