THIS DEED OF REINSTATEMENT AND VARIATION is dated the 14th day June of 2023

BETWEEN:

- (1) **THE CORNWALL COUNCIL** of Treyew Road, Truro, Cornwall, TR1 3AY (the "Council"); and
- (2) **VOLUNTEER CORNWALL** (Company Registration Number: 03562830 and Charity Registration Number: 1069957) of Acorn House, Heron Way, Newham, Truro, Cornwall, TR1 2XN (the "Service Provider")

each shall be a "Party" and together the "Parties."

WHEREAS

- (A) The Parties entered into a contract dated 01 April 2021 ("the Agreement") whereby the Service Provider agreed to provide the Services to the Council as set out in the Agreement and in respect of which the Council would pay to the Service Provider the Remuneration.
- (B) This Deed is supplemental to the Agreement.
- (C) The Council has agreed for the Service Provider to undertake further work pursuant to the arrangements set out in the Agreement.
- (D) The Parties have agreed to extend the Term of the Agreement subject to the variations to the Agreement as set out below.

IT IS HEREBY AGREED as follows:-

1. Definitions used in the Agreement shall have the same meanings when used in this Deed of Reinstatement and Variation unless expressly stated otherwise.
2. With effect from the date of this Deed the Parties agree:
 - a. that the Agreement has continued in full force and effect between 01 April 2022 and the date of this Deed on the same terms with the exception of Appendix 3 of the

Agreement which was updated to reflect an agreed annual value for the period 01 April 2022 to 31 March 2023;

b. that with effect from 01 April 2023 the Agreement was subject to the following variations:

- i. pursuant to Clause 2.3 of the Agreement, the Agreement shall be extended for a further period of twelve (12) months from 01 April 2023 until 31 March 2024;
- ii. with effect from 01 April 2023 the Parties agree that Appendix 3 to the Agreement is hereby deleted and replaced with the Appendix 3 attached hereto.

3. It is hereby confirmed that save for this Deed of Reinstatement and Variation the terms and conditions of the Agreement and any previous Deeds of Variation remain in full force and effect.
