- To obtain potential suppliers views and input into the specification

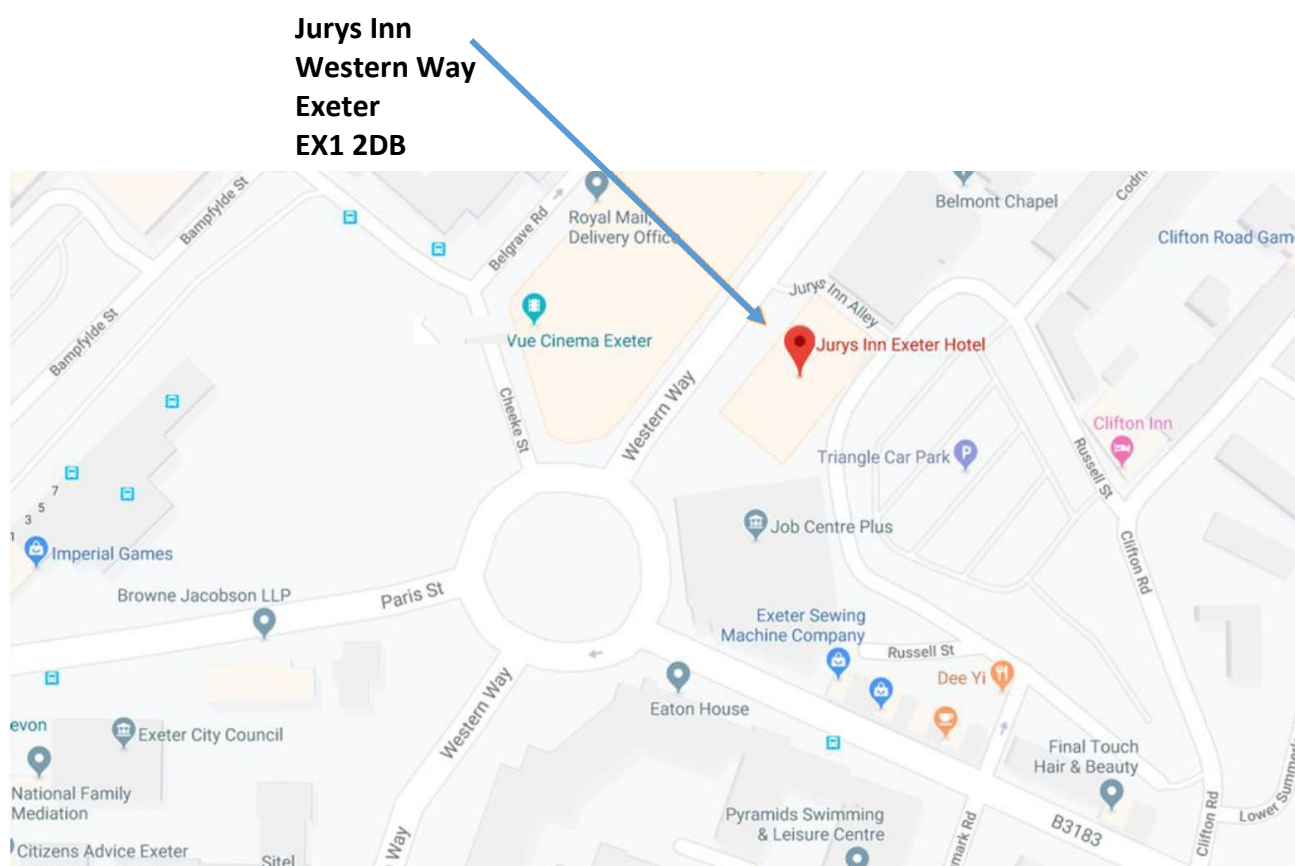
2.0 Your Invitation to Attend
