S 700 Tests and inspections

S 705 Tests and inspections

The *Contractor* shall carry out the following tests and inspections:-

- Goods, materials and sampling and testing of goods and materials,
- Testing for tar,
- Salt moisture content testing and
- *Client's* operational waste transfer stations.

Goods, Materials And Sampling And Testing Of Goods And Materials

The *Client's* requirements are set out in Clause 105 of the Specification for Highway, Works, Clause 105AR of the scheme specific specification in Scope S 2200 and Appendix 1/5 of the scheme specific specification in Scope S 2200.

The *Contractor* shall provide evidence of their Waste Management Plan, which takes account the applicable legislation. For the purposes of this Contract, as the 'producer' of waste, the *Contractor* is responsible for the identification, management and disposal of waste generated as a result of their works.

Testing For Tar

The *Client's* requirements are set out in Scope S 2200 *Client* service specification and drawings clause 977AR. Tests will be carried out by the *Contractor* when instructed by the *Service Manager*.

Salt Moisture Content Testing

The *Client's* requirements are set out in Clause 7808. Tests will be carried out by the *Contractor* under Winter Service Basic Facility.

Client's Operational Waste Transfer Stations

The *Client's* operational waste transfer stations are stated in Scope S 1000. The Contractor is to provide coverage, as set out in the Environmental Permitting Regulations 2007, by a Technical Competent Manager (TCM) with the Certificate Of Technical Competence (COTC) qualification. The requirements for attendance at each site are:-

- Podimore one visit each week, for one hour duration on each occasion.
- Bickenhall one visit each week, for one hour duration on each occasion.
- Minehead one visit each month, for one hour duration on each occasion.

Tests will be carried out by the *Contractor* under Basic Facility for Fixed Contract Overhead for Provision of the *Service*.

S 710 Samples

The *Client's* requirements for the supply and delivery of samples to the *Service Manager* are set out in Clause 105 of the Specification for Highway, Works, Clause 105AR of the scheme specific specification in Scope S 2200 and Appendix 1/6 of the scheme specific specification in Scope S 2200.

S 715 Management of tests and inspections and provision of samples

The *Client's* requirements are set out in Clause 105 of the Specification for Highway, Works, Clause 105AR of the scheme specific specification in Scope S 2200 and Appendix 1/5 and Appendix 1/6 of the scheme specific specification in Scope S 2200.

S 720 Service Manager's procedures for inspections and watching tests

The *Client's* requirements are set out in Clause 105 of the Specification for Highway, Works, Clause 105AR of the scheme specific specification in Scope S 2200 and Appendix 1/5 of the scheme specific specification in Scope S 2200.

S 725 Notifying and correcting Defects
